



AP degree in Financial Management

The AP degree in Financial Management consists of a compulsory part and an elective part. The compulsory part constitutes 90 ECTS and the elective part 30 ECTS, in all 120 ECTS.

Thematic structure

The teaching and learning approaches are based on themes. This means that all subjects cooperate on joint inter-disciplinary semester themes in order to link the individual subject elements and create a more holistic view.



Programme structure

The programme provides four semesters

1st semester:

Introduction to finance and methodology

2nd semester:

The financial sector and society

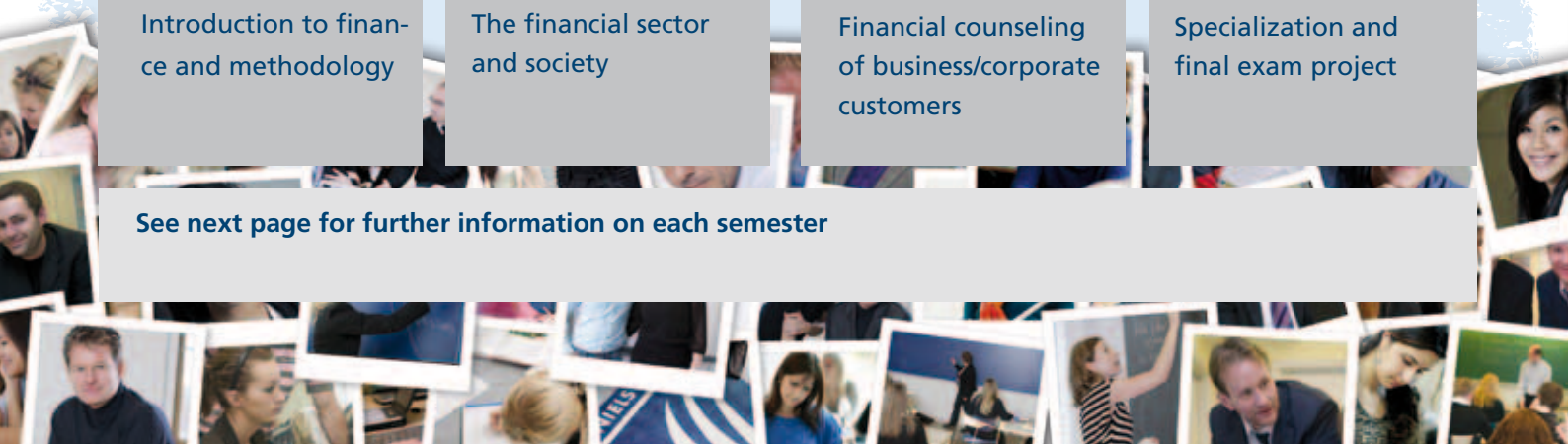
3rd semester:

Financial counseling of business/corporate customers

4th semester:

Specialization and final exam project

1st semester:

- Fundamental subjects
- The financial sector and financial products

2nd semester:

- Financial counseling of personal customers

3rd semester:

- Financial enterprises with the following mandatory subjects:
 - Financial Enterprises and Markets
 - Personal Economics
 - Customer/client Relations
 - Business Economics
 - Management and Communications
 - Global Economics
 - Business Law
 - Statistics

4th semester:

The specialization period (18 ECTS = approx. 3 months) consists of a work placement in Denmark or abroad

The final exam project (= 12 ECTS) should demonstrate the ability to work independently and methodologically with a complex problem within the area of finance and is usually done in cooperation with a company in Denmark or abroad.

Job and further education

After graduation you will be able to work with financial consultancy in for example a bank, a mortgage institution, an insurance company, a real estate broker, a real estate administrator, or in the finance department of a large private or public enterprise.

Access to further study

The AP degree in Financial Management gives access to relevant bachelor's programmes in Denmark and abroad. Typically it will take holders of an AP degree in Financial Management a year to 18 months to complete a Bachelor's degree.

Enrolment procedure

For students from Nordic/EU/EEA countries (non-European students below)

August start

There is no fee for students from Nordic/EU/EEA countries. You apply via the Coordinated Enrolment System in Denmark called the KOT. There are 2 forms: Application Form and Priority Form. Please download the forms from www.optagelse.dk

Deadlines for applications from European students: preferably by 15 March, but no later than 5 July (for August start).

For non-European students

Non-European students are obliged to pay full tuition fees. Immediately on receipt of conditional letter of acceptance and before applying for a visa to Denmark the student must pay Niels Brock the tuition fee for the first semester. The fee is non-refundable and will be forfeit in the event that the student fails to appear in Denmark and attend the programme, except if a visa application is rejected. In this case the tuition fee paid will be refunded less administration fee. Please contact Niels Brock for further information.
